The International Mountain Bicycling Association assistance agreement will help support trail construction within the Wood River Valley. Funds were obligated to this agreement in FY21 and trail construction began in early FY22.

Blaine County Recreation District (BCRD) Assistance Agreement is a multi-year agreement that assists with education and outreach efforts regarding trail conditions in the Wood River Valley along with assisting in maintenance of BLM trails.

#### **New Trails in Wood River Valley**




Trail Construction

The "Belle" and "Vue 1.0" trails were constructed in October and November 2021 just east of Bellevue, Idaho. The trails total 3.5 miles and are designated as motorized Class 1 e-Bike trails. This was the first phase/project implementing the Wood River Valley (WRV) Recreation and Access Decision Record. The trails were constructed partially by the BLM and an assistance agreement with the International Mountain Bicycling Association. The total cost of the project was\$46k.

#### **Recreation Fee Dollars**

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreationDirect operating or capital costs associated with the recreation fee program
